Areas of focus

- Gather information and make recommendations on discrimination against, threats or use of violence and harassment, directed at persons seeking to exercise or to promote the exercise of the right to freedom of opinion and expression, especially professionals in the field of information;
- The legal framework includes the *Universal Declaration of Human Rights* and the *International Covenant on Civil and Political Rights*;
- The right to freedom of expression includes the right to seek and receive information, as well as impart this information, through any media of one's choice.
